

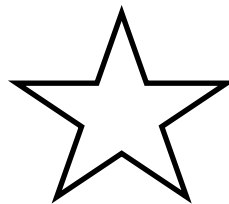
Students should enroll in August Company Classes in order to help prepare them for the audition they desire to attend. Auditions will be held during each company class time on August 26th. There is a \$20 audition fee per company due by the day of your audition.

After audition results are released, each Company member and Parent/Guardian is required to sign a contract stating understood and agreed participation in community events & competitions with dates and times that will be given at least 2 weeks in advance per event. Contract will also state that Company members and Parent/Guardians will represent the Everything Goes Dance Studio with professional, respectable, and positive behavior at/around the studio, in their technique classes, and at off-site events. These contracts will be discussed and signed at the **mandatory** EGD 2023-2024 Company meeting, September 9th, 3-4pm.

Being a part of a Dance Company will require each student to be enrolled in certain technique classes. Dedication and a love for dance is required! Dance Companies require some extra costs throughout the dance season as well, including competition fees. Parents often participate in our Company fundraising efforts to help balance out these costs if necessary. Please see our front desk or ask your company directors if you have any questions!
